**Pat Gehant** 

The meeting was called to order by Pat Gehant and opening remarks and introductions were made.

# 10:30 – 11:10 New Offerings/ Workforce Institute Reorganization

**Dr. James Connolly** 

Most of the Workforce Institute course offerings are being consolidated under 2 program coordinators: Innovation and Information Technology Coordinator (Fred Tucker) and the Business/Finance Coordinator (Kaitlyn Sussex).

### Global Corporate College (GCC) and customized training

**Belinthia Berry** 

- 767 people have been trained between July 2016 and now
- SPC has provided training for 40+ companies such as Achieva Credit Union and Pinellas County Government
- 1<sup>st</sup> GCC contract with Ceridian
  - o SQL training for Ceridian in Atlanta and eventually training in California and potentially in Toronto
- Received \$84,000 in net revenue in the first quarter

- Upcoming conferences in the Continuing Education Health area and Information Technology we are managing our SPC and other business conferences
- Companies have expressed a need for leadership and management training
- Pat Gehant suggested marketing our classes through conferences to businesses who have left the area and may return to the Tampa Bay area – connecting students with businesses
- Kathleen Waugh's last date with Workforce Institute is September 23, 2016; she is transferring to SPC's Human Resources department.

#### **Innovation and Information Technology**

**Dr. Susan Garrett** 

New grants and marketing with a focus on classes to guide students

David Hopkins reported strong 1<sup>st</sup> quarter sales numbers:

- Averaged \$200,000 in sales initially
- Increased sales
- New programs: Project Management, Drones/Unmanned Aerial Systems (UAS), CMA and CNA to CMA

Pat Gehant questioned the impact of closing of ITT. Dr. Connolly and David Hopkins responded:

- Students are degree-seeking
- ITT is not an accredited institution; it is difficult to transfer students into SPC's programs
- Everest and Fortis students in a similar situation
- Is there a possibility of these students transferring to our certificate programs?
- State will grant 6 credits if completed coursework meets our certificate requirements
- There are financial aid issues resulting from the school closures students do not have the ability to move over to a state school

Susan Garrett: Our programs are sold to individual students as well as to our corporate clients. More new programs are now being offered:

- Drones/UAS we have a complete curriculum now and the program is growing
- Combined information technology with innovative technology offerings go hand-in-hand
- Business and finance programs are consolidated
- CE Health programs are consolidated

### Fred Tucker, Coordinator for Innovation and Information Technology programs

- Traditional IT offerings continue
- UAS (drones) offerings 130 students have completed the drone course
- FAA has implemented new rules for operating drones 41 students have completed the program and 11 have passed the FAA certification test
- New courses coming:
  - o 1st UAS video editing course will be offered next month
  - o UAS entrepreneurship course
  - o UAS advanced flying course
  - Podcasting courses: the first of four classes will be offered next month; the instructor spoke with the SPC MIRA program about these new podcasting classes to be offered

# Kaitlyn Sussex, Coordinator for Business and Finance Programs

- Project Management course (PMP/CAPM certification course)
  - o 18 students enrolled in the first quarter, 8 more than projected
  - o There are no certification numbers yet, the students have not yet tested
- Entrepreneurship program to come; it is in the early planning stage
  - o Currently feeder classes to the entrepreneurship program are offered
  - Entrepreneurship program will be a two-week program one week in class and one week as a CAPSTONE project, and finally a class presentation
  - o Digital marketing strategies is an example of feeder class

### Susan Garrett, CE Health programs

- There has been an increase in students and instructors from closing for-profit schools
  - o Phlebotomy
  - o CNA to CMA
  - Medical scribe and transcription
- Looking to expand CMA to be considered financial aid eligible
  - Offering classes at the Midtown campus, and soon to be at the Oldsmar location and possibly the Tarpon Springs campus
- New relationship with the Salvation Army
  - o Adult rehab. center on 66<sup>th</sup> Street
    - David Hopkins met with some of the residents
    - Our course information will become part of the residents' intake program
    - Certifications in MSSC/CPT one of the programs

- SPC apprenticeship grants
- Pathways to Hope grant
- Prepping the first group of 19 residents to test

Sean Kennedy asked if the program could be applied to other populations, and Susan Garrett responded yes: Goodwill, Urban League and CASA.

Susan Garrett noted that she and Susan Colaric are working to develop certifications in instructional design/instructional technology.

- The need is there in the corporate world for these courses
- 4 (?) new certifications. certificates embedded in other certifications
- Create a professional association for these occupations at SPC could be a pipeline to funnel these students into these new programs
- Hope to fully launch by May 2017

Pat Gehant asked about a survey course on IOT (Internet of Things) – is this a possibility.

- Tech Data does this
  - Can this be a new course through SPC
  - Instructors from Tech Data
  - Introduces students to explore ideas for IT uses
- Are we creating courses attached to specific certifications?

Susan Garrett: Not all courses lead to certifications; we are building classes to lead to a certification or industry need.

Pat Gehant: Do we map our programs to an academic degree? Susan Garrett responded that the Pathways model is a way to map our programs to a degree program; our programs are also a career pathway without a degree.

Tom Morrissette: How to get employers to speak with educators as to what they need, e.g., Association Management program needed.

Abdul Lateef: Specific degrees

- Connecting industry needs with job pool
- Not many qualified candidates available
- Once hired, further career development of employees—managers have to find the classes and programs for their employees

Joan Read: There is a need for replacing craft workers who are aging out of the county labor force

- Craft workers aging out and need for new people in their skillset
- Leadership performance need help with moving metrics of evaluation of groups to individuals: leadership training needed
- Apprenticeship program for crafts people would be helpful
  - o County has favored hiring of experienced people moving to the area
  - How to create a system to transfer body of knowledge to a newer, younger population.

Sean Kennedy: The City of St. Petersburg is in need of developers.

Pat Gehant: The chambers can market to the Northeast to attract workers.

Kerry Carter (Career and Academic Advising, MT Campus): Regarding the CMA program, asked about financial aid for students. David Hopkins suggested phlebotomy – there is a grant available for this program.
