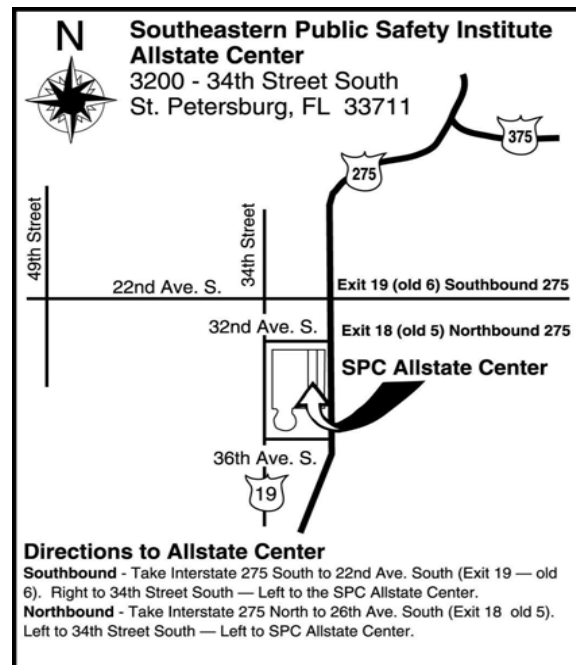

CERTIFICATION INFORMATION

F.S.S. 828.27(4)(b): "The governing body of a county or municipality may impose and collect a surcharge of up to \$5 upon each civil penalty imposed for violation of an ordinance relating to animal control or cruelty. The proceeds from such surcharges shall be used to pay the costs of training for animal control officers."

F.S.S. 828.27: The statute requires **county-employed** animal control officers to successfully complete a 40-hour Florida minimum standards training course. **City-employed** animal control officers may complete the course, but the state does not require them to do so.

This course of training has been approved by the Florida Criminal Justice Standards and Training Commission under provisions of §943.14(4.9) and §943.25(8) Florida Statutes.
