- The following weapons are allowed: .38 caliber revolver, .380 caliber, 9 millimeter semiautomatic pistol or .357 caliber revolver with .38 caliber ammunition only.

- No open toe shoes, feet should be fully covered
- No red shirts or red caps or tank tops
- Baseball type cap

Range Time: Each student will spend a maximum of 8 hours range time, no remediation.
