Florida State Statute 493: Requires that an applicant for Class “D” License must complete a minimum of 40 hours of professional training. Applicants may submit an initial application with proof of completing Course A (24 hours) of professional training. They also must complete Course B (16 hours) of training within 180 days following the submission of the initial application.
