### ABOUT THE PROGRAM

If you are a licensed practical nurse (LPN), you can earn credit for your experience and education toward SPC's Associate in Science Nursing degree. This program gives you the technical skills and scientific background you need to succeed in this lucrative field.

- New students must complete the St. Petersburg College Admission Application and pay the non-refundable fee. Returning students must complete the online Readmission steps in MySPC if you have not enrolled in the previous six semesters. [Admissions and Readmissions](#)

**A secondary Health Program Application is required for limited access Health Programs (link on page 2)**

- Submit official, unopened (sealed) high school or GED transcripts indicating completion of standard high school diploma or equivalency. We do not accept unofficial copies or official copies that have been opened. Applicants who have earned an Associate in Arts, Associate in Science, Associate in Applied Science, Baccalaureate, or higher degree from a regionally accredited institution are waived from this requirement. **Transcripts must be received and evaluated by St. Petersburg College prior to the application deadline to ensure consideration.** [Submitting Official Transcripts](#)
- Submit official, unopened (sealed) transcripts from all regionally accredited college(s) and/or universities currently or previously attended. We do not accept unofficial copies or official copies that have been opened. **Transcripts must be received and evaluated by St. Petersburg College prior to the application deadline to ensure consideration.** [Submitting Official Transcripts](#)
- Students must demonstrate they are at college level in Writing, Reading, and Math either through appropriate test scores or through appropriate course completion.
- Students must have a cumulative grade point average of 2.00 on a 4.00 scale in all postsecondary coursework. Academic Standing may have an impact on admission, enrollment, and financial aid eligibility. See the SPC Academic Standing Policy for details. [Academic Standing Policy](#)
- Students must successfully complete all pre-entry requirements within three attempts. Attempts include transfer credits, course substitutions, test credits, and SPC course withdrawals (WR marks not included).

- Pre-Entry Requirements to be completed with a minimum grade of “C” and earn a minimum 2.75 GPA on a 4.00 scale by the application deadline. The following courses are used for the pre-entry requirement admission GPA.

The following courses must be completed by the application deadline:

- BSC 2085/2085L - Human Anatomy and Physiology I and Lab
- BSC 2086/2086L - Human Anatomy and Physiology II and Lab
- ENC 1101 or approved Communications Core (May be satisfied by an Associate in Arts or higher degree)
- Computer/Information Literacy Competency (May be satisfied by an Associate in Arts or higher degree) no minimum grade, not calculated into the pre-entry admission GPA

At least two of the following courses must be complete with a “C” or better by the application deadline. For the one remaining course, you must currently be enrolled at SPC (summer term for fall admission or fall term for spring admission) and complete the course with a “C” or better to maintain program eligibility.

- MCB 2010/2010L - Microbiology and Microbiology Laboratory
  - POS 2041 - American National Government or (POS 2041H)
    - **or** AMH 2020 - History of the United States II or (AMH 2020H)
    - **or** AMH 2010 - History of the United States II or (AMH 20100H) – fall 2024 or thereafter
  - STA 2023 – Elementary Statistics or (Honors)
- Earn a 2.75 minimum GPA on a 4.0 scale in the science pre-entry requirements: BSC 2085, BSC 2085L, BSC 2086, BSC 2086L, MCB 2010, and MCB 2010L.
  - ATI TEAS Test – Completed within 12 months prior to the Nursing Program application deadline (see ATI TEAS test window dates page 1). Find out how to register and request a transcript for the [ATI TEAS Test](#). Retakes are based on ATI’s minimum standards retake policy.
  - VECHS/FDLE forms: Applicants offered admission are required to print, hand sign, scan (either by scanner or mobile PDF app), and upload both fully and properly prepared [forms](#) in the Notice of Intent (NOI) survey. If admitted, further details on completing the background check, drug testing and fingerprint screening processes will be provided in the offer of admission email.
  - Submit the Health Programs Application for the Associate in Science in Nursing Program at <https://web.spcollege.edu/hec/application/apply>
    - Enter the clear and active Florida LPN license number or LPN license number from a state participating in the Nurse Licensure Compact in the application.
    - Immediately after application submission, applicants will receive an email confirmation to their SPC xxxxxx#@live.spcollege.edu email account which will include instructions on next steps and how to submit the Video Interview and Healthcare Experience Survey form. **These items are due by the application deadline.**

## Selection Criteria

Due to enrollment limitations, meeting minimum requirements does not guarantee admission. When the number of eligible applications exceeds program availability, selective criteria is used to determine which applicants are offered admission. The College of Nursing determines which applicants will be offered admission utilizing the point values outlined below:

Points will be assigned as follows:

- Pre-entry requirement admission GPA.
  - 3.7 to 4.0 = 15 points
  - 3.5 to 3.699 = 13 points
  - 3.2 to 3.499 = 11 points
  - 3.0 to 3.199 = 9 points
  - 2.75 to 2.99 = 5 points
- Pre-entry requirements taken at SPC.
  - All 21 credits taken at SPC = 10 points
  - 15-20 credits taken at SPC = 7 points
  - 10-14 credits taken at SPC = 4 points
  - Less than 10 credits = 0 points
- ATI TEAS score based on proficiency level
  - Exemplary = 40 points
  - Advanced = 35
  - Proficient = 25
  - Basic = 10
  - Developmental = 0
- Video Interview (10 points maximum); see application auto-confirmation page for more detailed instructions
- Work experience in health care (10 points) see **Work Experience Criteria** on next page for criteria details

**If you are admitted**, you will need to complete the following pre-enrollment requirements to maintain eligible status.

- Complete the Notice of Intent (NOI) survey by the date indicated in the admission email. Candidates on the Alternate list must also submit an NOI for consideration if a seat becomes available.
- Successfully pass a [background check and drug screening](#) by the date indicated in the admission email. (Completion required within 2 weeks of admission offer)
- Attend the mandatory Health Education Program orientation on the date indicated in the admission email. Please clear your calendar so you are available to attend if you are offered admission; Fall term – mid July, Spring term – mid November.
- Complete the Health Examination Form, all details will be provided during the Nursing Orientation.
- Candidates on the Alternate list must follow instructions and deadlines provided in their admission email to maintain eligibility for possible admission. If you are not notified of being moved from the alternate list to that admit list, a new application will be required during the next appropriate application period.
- If admission offer is declined by the student, a new application will be required during the next appropriate application period; applications do not rollover to future terms.

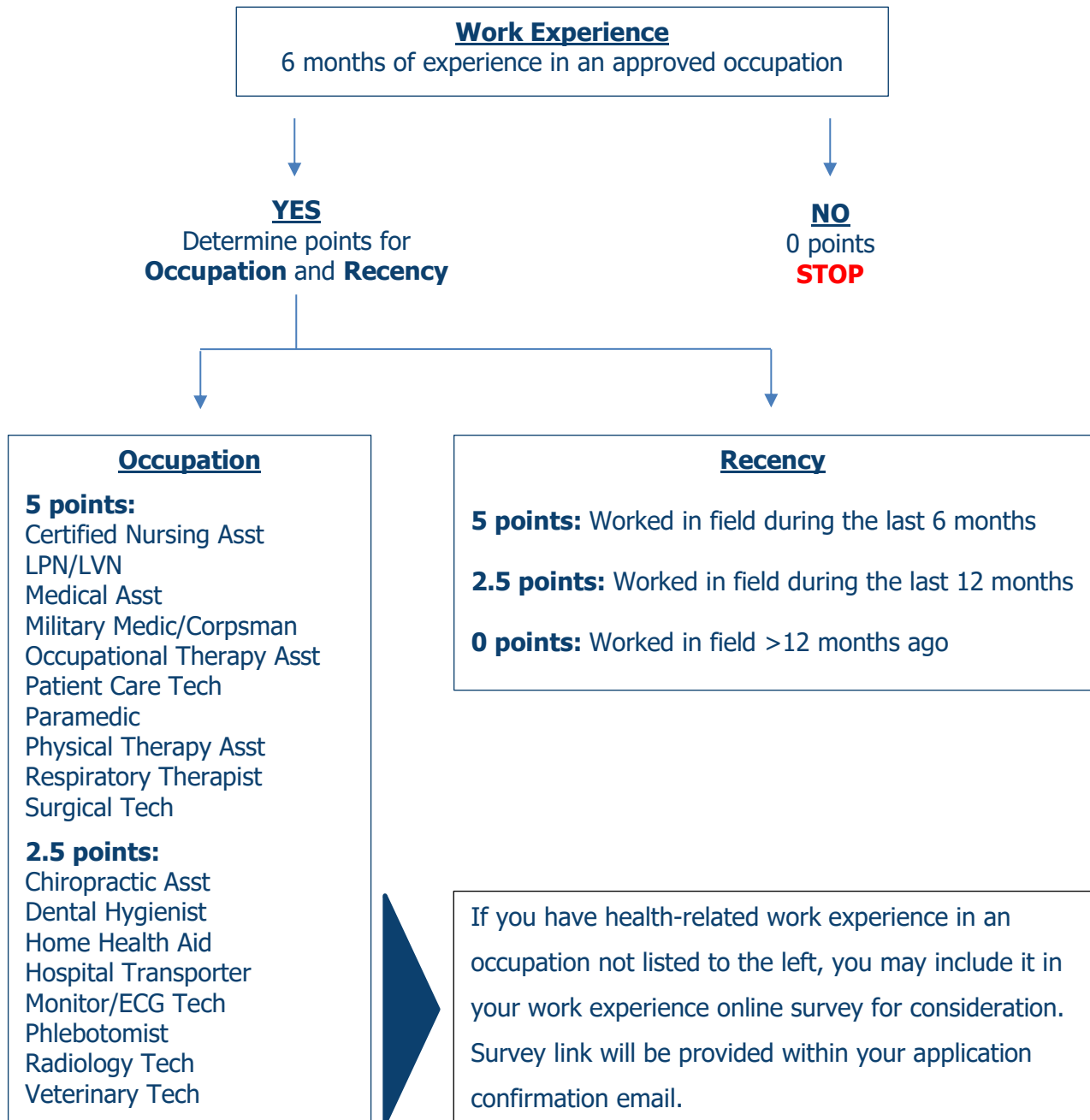

## Work Experience Criteria

The work history criteria is designed to identify applicants with recent and relevant experience in the healthcare field, particularly those who have engaged in direct patient care and interaction. This experience demonstrates a basic understanding of the responsibilities and communication skills essential for success as a nursing student. Additionally, it highlights a commitment to the healthcare profession and a foundational knowledge that can support academic and clinical success.

### This applies to RN, LPN-to-RN, and Paramedic-to-RN applicants



## Program Information

Clinical facilities may prohibit students who do not have an assigned social security number from participating in clinical experiences which are a mandatory component of the curriculum. If other placement options are not available, the student would need to withdraw from that semester and would not be able to progress in the nursing program. These factors must be taken into consideration prior to pursuing admission to the nursing program.

Fall Only: Day theory schedule (Fall, Spring, Fall)

- Three semesters with summer off
- Theory courses are in the afternoon (usually 1pm-6pm) - 1 day per week + online courses
- Simulations are in the afternoon (usually 1:30pm – 7:30pm) - 1 day every other week
- Clinicals are 1 day per week (M-F, varies) from approx. 6am - 5pm

Spring Only: Evening courses with weekend clinical (Spring, Fall, Spring)

- Three semesters with summers off
- Theory courses are in the evening (usually 5pm - 9pm) - 1 day per week + online courses
- Simulations are in the evening (usually 5pm - 8pm) - 1 day every week
- Clinicals are 1 day per week on Saturdays from approx. 6am - 5pm
