The Board of Trustees of St. Petersburg College announces a public meeting to which all persons are invited.

DATE AND TIME: January 20, 2026; Board meeting commencing at 9:00 a.m.

PLACE: The meeting will be held at the Tarpon Springs Campus of St. Petersburg College, Chris Sprawls Workforce Hub, 600 E. Klosterman Road, Tarpon Springs, Florida.

PURPOSE: The meeting will be held for the purpose of considering routine business, and other matters that come before the Board including adopting or amending rules of the Board of Trustees pursuant to its rule-making authority.

A summary of the proposed rules and/or amendments, together with the purpose and effect and specific legal authority, will be posted no later than Friday, December 12, 2025, on the official bulletin boards as follows: at the St. Petersburg/Gibbs and Clearwater Campuses in the entrance to the libraries; at the Tarpon Springs Campus in the Lyceum Building across from Room LY 104; at the EpiCenter—Services Building, on the first floor east corridor across from Conference Room SR-110; at the EpiCenter outside of Room 1-122; on the east wall, across from the seating area under the stairs, at the Health Education Center; outside Room TL 106 in the Technology Learning Center at the Seminole Campus; on the west wall of the facilities/mailroom area outside room AC 134 at the Allstate Center; on the bulletin board next to the Provost Office on the first floor of the SPC Downtown Center; close to the stairs on the north wall and outside near the parking lot on the east wall at the Douglas L. Jamerson, Jr. Midtown Center; at the Veterinary Technology Center near the front entrance and in Room 166; and advertised in a newspaper of general circulation, in the Titan News, and on the College's website.

If requested within 21 days after the date of publication of this notice, a hearing on the proposed rule(s) or amendments thereto will be held at 9:00 a.m. or soon thereafter on January 20, 2026, at the Tarpon Springs Campus of St. Petersburg College, Chris Sprawls Workforce Hub, 600 E. Klosterman Road, Tarpon Springs, Florida. See Section 120.54(3)(c), Florida Statutes.

Any person who is substantially affected by the above rules may seek an administrative determination of the invalidity of any proposed rule on the ground that proposed rule is an invalid exercise of the Board's delegated legislative authority. Such request shall be by Petition in writing and filed within 21 days after the date of publication of this notice. See Section 120.56(2), Florida Statutes.

Any person who wishes to provide the Board with information regarding the statement of estimated regulatory costs, or to provide a proposal for a lower cost regulatory alternative as provided by Section 120.541(1), Florida Statutes, must do so in writing within 21 days after the date of publication of this notice.

Members of the public are given the opportunity to provide public comment at meetings of the Board of Trustees concerning matters and propositions on the agenda for discussion and Board action. At the Board meeting, in advance of the time for public comment on the agenda, individuals desiring to speak shall submit a registration card to the Board Clerk, Rebecca Brown, at the staff table. 1. RULE TITLE: GRADUATION REQUIREMENTS FOR ALL DEGREES, CERTIFICATES AND DIPLOMAS 6Hx23-4.24

SUMMARY, PURPOSE, AND EFFECT: The proposed changes to the Rule will update titles for certificates and diplomas to align with the language used by the state of Florida.

2. RULE TITLE: GRADUATION REQUIREMENTS FOR THE ASSOCIATE IN SCIENCE AND ASSOCIATE IN APPLIED SCIENCE DEGREES 6Hx23-4.29

SUMMARY, PURPOSE, AND EFFECT: The proposed changes to the Rule will repeal the Rule which is no longer necessary.

LAW IMPLEMENTED: 1001.64(4)(a) & (b), F.S.

3. RULE TITLE: INSURANCE AND RISK MANAGEMENT 6Hx23-5.08

SUMMARY, PURPOSE, AND EFFECT: The proposed changes to the Rule will change the title to the Rule to *Insurance Programs* and update the Rule to align the College's insurance offerings through the Florida College Risk Management Consortium and the College's insurance broker.
