<b>1. Old Business</b>	<b>A/B.</b> Copies of November 7, 2013 minutes were emailed to all ACM.	Will need to approve minutes at next meeting.
<b>2. New Business</b>	<p><b>1. Recommended Changes for the 10K Curriculum</b> CCIT Faculty, Chairs, Academic Coordinator and Dean reviewed all Certifications and AS Degrees for hidden pre-reqs and made sure all courses are up to date. There have been courses added to the BAS and additional subplans. Some of the new courses concentrate on soft skills as well. Internships and apprenticeships have been added. CCIT is hoping to partner with companies to have intern and/or apprentice credits paid for by the company they intern or apprentice with. The name of the BAS degree is changing to Technology Development and Management.</p> <p>The major courses within the degree have been decreased from 36 to 30 in order to have 5 classes in each subplan. ## 2. Accelerated Credit Mechanisms

Students receive credits for Industry Certifications. For example; if a student enters SPC within 3 years of acquiring a CCNA Certification they will receive 12 credit hours as long as they sign up for an AS degree which coincides with their Certification. If there are any certifications that Nancy has missed on the spreadsheets please let her know along with the type of course that could be received for the particular certification. For the BAS degree a student could use CISSP or PMP. Nancy needs some help with some of the Industry Certifications she is not familiar with.

Joe shared that students in the 9<sup>th</sup> grade are getting certifications and the movement is toward middle school students getting certifications. This timeframe does not work with the 3 year limit the state has instituted. This needs to be brought to whoever is responsible at the state level.

It was suggested that Oracle be accepted for credit. Also Military Certs or training should be accepted as well. CCIT will be looking at Military Certifications or training in conjunction with the \$10K BAS.

## 3. Curriculum Updates

CGS 1000 will be changing to COP 1000.

Web Design will be changing to Web Development. Java and Javascript will be added to the curriculum. Also Collaborative Technologies will be added which will teach about Facebook, Twitter, etc.

## 4. Portfolio for the \$10K Student

### **5. Apprenticeship Capstone**

Dr. Law would like to see the Apprenticeship Capstone become 6 credit hours. CCIT will be looking to partner with local companies like those represented here by our ACM members.

It was suggested that we use our own marketing students here at SPC to market to area businesses. Also maybe use project management students need to work with the College of Business.

The more companies we could get to partner with us the more possible it would be to have students in internships and apprenticeships credit paid for by those companies.

### **6. Sub-Committee Reports**
