

## **Criminal Justice Technology Associate in Science Degree**

## **Admission Requirements**

- Complete the <u>St. Petersburg College Admission Application</u> and pay the \$40 non-refundable fee.
  \*Note to returning students: If you have not enrolled in courses for six previous semesters, you will need to complete the online <u>Readmission Application in MySPC</u>. You will be asked if you want to complete the readmission process when you log in to MySPC. Failure to do so will prohibit or delay your course enrollment.
- □ Submit official, unopened (sealed) high school transcript(s) or GED transcripts. Applicants who have earned an Associate in Arts, Associate in Science, Associate in Applied Science, Baccalaureate, or higher degree from a regionally accredited institute are waived from this requirement but must submit all transcripts documenting degree completion. Unofficial copies or official copies that have been opened are not acceptable.
- □ Submit official, unopened (sealed) transcripts from all regionally accredited colleges and/or universities. We do not accept unofficial copies or official copies that have been opened.

## **Program Information**

The goal of this program is to prepare the student with a diverse background in the history, philosophy, organization and operation of the various arenas of public safety and their respective processes. The flexibility of this degree is that the student is allowed to select an option/sub plan and still be able to receive a well-rounded foundation of the public safety field. The Associate in Science degree program allows students to not only graduate with an AS degree, but also be able to meet the entrance requirements to continue the <u>BAS degree in Public Safety Administration</u>. Please NOTE: This program does not prepare you for certification as a Correctional Officer, Law Enforcement Officer, Correctional Probation Officer, Auxiliary Correctional Officer or Auxiliary Law Enforcement Officer. You must successfully complete a Criminal Justice Standards and Training Commission (CJSTC) Basic Recruit Program, such as one of SPC's training academies, to become a certified officer through FDLE.

# **ADDITIONAL INFORMATION: Law Enforcement and Corrections Subplans Only**

- 1. Must have permission of the program office before registering.
- 2. Students enrolled in the Degree, and planning on completing the Law Enforcement Academy, should not take the following courses until admitted into the Academy:
  - CCJ 1020 Intro to Criminal Justice
  - CJL 2062 Constitution Law & Rules of Evidence
- 3. Must have completed the St. Petersburg College Basic Law Enforcement Academy or Basic Corrections Academy, taken and passed the FDLE State Exam, and completed any necessary preparations to have these academy credits transferred to or accepted by SPC. Other credits may be awarded from other FDLE Certified Training schools via the SPC Experiential Learning Program. Students who pass the Law Enforcement Academy state exam will be awarded up to 30 credit hours towards the <u>AS Degree in Criminal Justice Technology</u>. This will include the following courses:
