1. RULE TITLE: MEETINGS OF THE BOARD OF TRUSTEES 6Hx23-1.04

SUMMARY, PURPOSE AND EFFECT: The proposed changes to the Rule will update information in the Rule regarding what constitutes a quorum of the Board; establish the definition of Board members being “present” at meetings; and include information on the attendance of Board members.

3. RULE TITLE: EMPLOYMENT OF CAREER SERVICE EMPLOYEES – STANDARDS OF CONDUCT, DISCIPLINE AND CORRECTIVE ACTION 6Hx23-2.19
