## TUITION

### Tuition Due Dates

Universal Due Date for Winter Session, Full Term, Weekend College and First 8 Week Session for enrollment between Oct. 23 and Dec. 13 ..... Dec. 13

*If your tuition is not received or if you have not been awarded financial aid by this date, the classes you have registered for will be removed from your schedule. You can re-register for classes on a space-available basis.*

Financial Aid Awarded Date for FAS Due Date Extension for enrollment between Oct. 23 and Dec. 13 ..... Dec. 13

*You can still apply for financial aid after this date; however, you will need to make arrangements for tuition payments while your file is processed.*

Second Due Date for Winter Session, Full Term, Weekend College and First 8 Week Session for enrollment between Dec. 14 and Jan. 5 ..... Jan. 5

*If your tuition is not received or if you have not been awarded financial aid by this date, the classes you have registered for will be removed from your schedule. You can re-register for classes on a space-available basis.*

Second Financial Aid Awarded Date for FAS Due Date Extension for enrollment between Dec. 14 and Jan. 5 ..... Jan. 5

*You can still apply for financial aid after this date; however, you will need to make arrangements for tuition payments while your file is processed.*

Residency documentation for Full Term, Weekend College and First 8 Week Session tuition purposes submission date ..... Jan. 16

Due Date for Express Session ..... Feb. 2

FAS Due Date Extension ..... March 28

*This extension is for students who are awarded a financial aid package by Dec. 13 or Jan. 5. If your financial aid award does not cover the entire balance, you must pay your balance by this date. Students with an extended due date will not be dropped for non-payment by this date. The student may continue in the class, but will be billed for the amount owed. Future registration and official transcripts will not be available until the balance is paid in full.*

25% down payment with 3 monthly payments and \$35 enrollment fee ..... Dec. 14  
(Dec., Jan. & Feb.)

50% down payment with 2 monthly payments and \$40 enrollment fee ..... Jan. 12  
(Jan. & Feb.)

Last date to increase the payment plan agreement balance ..... Jan. 12

Last date to decrease or terminate payment plan agreement balance ..... March 19

Awarding	Financial aid awarding occurs DAILY, email notifications are sent DAILY
Verification	14 working days from the receipt date of all required documentation <i>Once complete, the verification item(s) will be removed from your MySPC To Do List.</i>
SAP Appeals	15 working days from the receipt date of all required documentation, email notifications are sent DAILY <i>Once a decision is made, the SAP item will be removed from your MySPC To Do List. To check the current SAP status, login to MySPC, select "Financial Aid Status," select the aid year and look in the box in the top right-hand corner.</i>

**Students will be notified by email if, during peak processing times, the benchmarks above have been revised.**
